

6. Definitions. "Activities" include, but are not limited to the following activities which may be provided, hosted, facilitated and/or sponsored by DPS: self-exploration experiences involving the use psychoactive substances, integration counseling services, microdosing nature hikes, yoga and meditation, group gatherings, retreats and events, local excursions and day tours, transportation in DPS or other vehicles, training classes, workshops and instruction, traveling to and from DPS Offerings, and all other activities associated with DPS Offerings.

"Risks" include, but are not limited to those known risks inherent to the Activities specifically listed below, vehicular travel and traffic, road and trail conditions, known and unknown health conditions, allergies, sudden weather changes, rain, wind, hail, lightening, high altitude or motion sickness, dehydration, heat stroke, snake bite, bee and other insect stings and/or bites, wild and domestic animals, inaccessibility to immediate medical attention, falling rocks and trees, and acts of God.

Risks inherent in using psychoactive substances and related activities including, but not limited to the mind-altering effects of using psychoactive substances in various doses and settings with varying levels of guidance and support before, during, and after the exploration experiences, are risks and conditions that are an integral part of these Activities including but not limited to interactions between psychoactive substances and some prescription medications present in the participants system, digestive system discomforts, nausea, dizziness, vomiting, diarrhea, and varying levels of temporary physical impairment.

Risks inherent in recreational activities including, but not limited to hiking, participation in yoga, swimming, local excursions and day tours, are dangers or conditions that are an integral part of the recreational activities, including but not limited to sudden weather changes, rain, wind, lightning, Participant's physical condition or exertion for which Participant is not prepared and/or motion sickness, dehydration, heat stroke, wild or domestic animals, insect bites and/or stings, distance and inaccessibility to immediate medical attention, travel over rough terrain, driver error, Participant error, facilities, actions of other people, and acts of God.

7. Certification and Assumption of Risk. Participant hereby certifies that he/she is sufficiently physically and mentally fit for participation in DPS Offerings and has not been advised otherwise by a qualified medical person.

Participant agrees that DPS is not qualified to evaluate Participant or Participant's fitness for involvement in DPS Offerings beyond the employment of a limited participation screening process. Participant must determine if he or she is sufficiently fit to participate. Participant hereby expressly and specifically assumes the risk of injury or harm in the Participant's involvement in DPS Offerings, including, but not limited to all Risks. Participant agrees that his/her involvement in DPS Offerings is purely voluntary, and Participant elects to participate in DPS Offerings in spite of the Risks.

PARTICIPANT'S STATEMENT:

I am responsible for my health and I understand that my participation in DPS Offerings may pose some risks. To the best of my knowledge, I am in good physical condition and I am not aware of any physical or psychological infirmity, which would place me at risk to participate in any way. In the event of a medical emergency, I agree to seek emergency medical care and give permission to initiate contact with emergency medical providers. I will utilize appropriate support so that I may optimize the benefit of this experience, and reduce any risks.

In consideration of being allowed to participate in DPS Offerings, I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE DPS, it's leaders, organizers, hosts, staff members, service providers and participants from any and all liability, claims, demands, or course of action whatsoever arising out of, or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me whether caused by the negligence of release, or otherwise, while participating in "DPS Offerings", or while in, on or upon the premises where the Activities are being conducted.

I agree to indemnify and hold harmless those with whom I engage in DPS Offerings. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISK OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or any loss or damage to property owned by me as a result of being engaged in DPS Offerings whether caused by the negligence of release, or otherwise.

By signing this release below, I acknowledge and represent that I have read, understood and signed the form voluntarily; I am an adult, of at least eighteen years of age or older, and fully competent; and I execute this Release for full, adequate and complete considerations fully intending to be bound by same.

This waiver applies to all present and future participation in DPS Offerings.
